

For example, by the end of the first chapter, readers will know exactly what the difference is between an organization that is merely â cesmartâ • and one that is â cehealthyâ • and why it is infinitely more preferable to be healthy. This book contains a wealth of information and is a must-read for anyone who happens to be in a position of leadership within an organization. That being said, this book cannot ultimately replace the kind of consulting work that most organizations need, and organizations wishing to benefit from the plan Lencioni lays out would do well to seek out the help of his firm or others like it.
